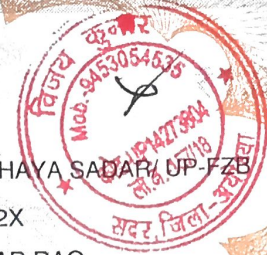

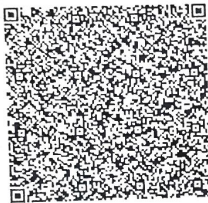

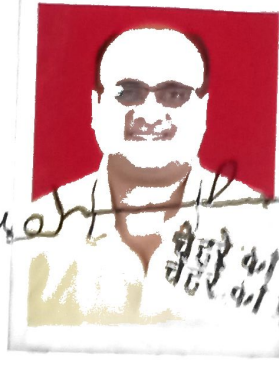

ADMINISTRATION OF THE TRUST:

The administration of the TRUST shall vest with the Board of Trustees, which consist of. -

- a) One Main/Chief Trustee,
- b) Two Trustee Appointed by Main/Chief Trustee.

All the above said parties will be collectively called the TRUSTEES which expression shall include them, the survivors of them and the executors and administrators of the last survivor or the Trustees for the time being of the Trust created hereby.

NOW THIS TRUST DEED WITHNESES AS FOLLOWS:

01. The name of the Trust shall be **SANATAN SAKET DIVYA DHAM TRUST**
02. That the registered office of the Trust shall be situated at Dakshin Modaha, Khojanpur, Faizabad, Tehsil- Sadar, District-Ayodhya, India, or at such other place or places as the Board of Trustees may decide from time to time. Branch / administrative offices can be opened in any part of the world for the smooth functioning of the Trust.
03. The Board of Trustees shall hold a sum of Rupees 5,000.00 (Rupees Five Thousand Only), this day paid to them. There is no other movable and immovable property held with Trust at present.

All monies, funds, other movable or immovable properties and incomes thereof which may hereinafter be received by the Board of Trustees from time to time




as Gifts, Donations, Grants, Subscriptions or otherwise for the purposes of the Trust and the Trust fund shall vest in the Trustees jointly.

04. That the objectives of the Trust shall be wholly for the public and charitable purposes and incomes shall be applied for the same and accumulated in India wholly for public & charitable purposes without prejudice to generality of provisions aforesaid and the following shall be deemed to be the principal objectives of **SANATAN SAKET DIVYA DHAM TRUST**:

- 4.1 To preserve and peach the Hindu Culture and Religion and to spread the concept of Sanatan Hindu Religion.
- 4.2 To promote quality livelihood to rural citizens of India by taking help and helping various non-profit organizations, agencies and corporate, public, private and government institutions.
- 4.3 To establish maintain and run studentship, scholarships and render other kind of aid to students including supply of books, stipends, medals and other incentives to study, without any distinction as to cast, creed or sex.
- 4.4 To protect and promote cows, educate people about cows, and provide care for cows in need, preserve and improve the Indian cow breed, protect cows from cruelty, neglect, and destruction, promote non-violence and compassion for animals.
- 4.5 Provide care for cows Provide medical assistance to sick cows, Provide fodder for cows, Cremate dead cows properly, and Run cow shelters (gaushalas).
- 4.6 To establish, maintain or grant aid to homes for the aged, orphanages or other establishments for the relief or to the poor, needy and destitute people, orphans, widows and aged persons.



- 4.7 To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.
- 4.8 To work in collaboration/partnership with other likeminded institution/agencies both government and non-government in the direction of public awareness, health, environment, education and services etc
- 4.9 To conduct research studies on the social and economic conditions of people with a view to involving ways and means for their development within their social historical frameworks and to seek promotion of rural development such as provision of drinking water, rural industrialization as well as Public Convenience for people.
- 4.10 To spread the spiritual consciousness to bring human beings to mainstream of the trust, with an intention to lead pious life and to develop fellow feelings and fraternity..
- 4.11 To call for Dharma sava, Yogi, Rishi, Muni and all cultured and distinguished peoples of India and a broad to deliver their learning and part with their thought, idea and concept.
- 4.12 To protect and promote the interest of the members of the Trust in respect of all legitimate claims, demands for the development of the Deity and Temple.
- 4.13 To popularize and organize Nama Sankirtan, Bhajan, Janan, Sevapuja of the Deity and to publish religious books.
- 4.14 To establish hospital, dispensary and to install medical instruments such as X-ray, scanning machine, laparoscopy instruments, instruments for cancer and for other disease treatment of whatsoever nature to serve the diseased and poverty stricken people for charitable purpose.
- 4.15 To arrange free distribution of food and water to the needy people and render other sorts of assistance for shelter etc. as far as practicable.







- 4.18 To inter – change its experience,ideas with other organization and take the help of various organization in respect of the developmental work in furtherance of its aims and objects and to contribute/donate to similar and like minded religious and educational institutions and Ashrams or to receive donations from such sources.
- 4.19 To publish Journal,magazines,periodicals,leaflets and such other literatures as may be deemed necessary to pursue its objectives and to encourage education and research on literature,science,arts,mythology,veda,purana,Upanishad,etc..
- 4.20 To take steps to raise adequate resource including borrowing,aid,contribution,subscriptions from members,institutions,government,corporation,general public in cash or in kind in furtherance of all acts relating to the foregoing objectives of the Trust.
- 4.21 To construct, maintain, alter, improve, or develop any building belonging to the trust or works necessary or convenient for purpose of the trust.
- 4.22 To arrange / establish and maintain centers of adult education, vocational education technical training, low cost education, formal & non-formal education.




- 4.23 To dig wells and ponds, water reservoirs, with the purpose of public benefit. To establish manage, adopt, organization/industries/individual to augment financial strength to be utilized for charitable purposes And to render assistance, to renovate their temples, well and tanks, Natya mandir, Toran, puja mandap, Asthan & Singhasan et
- 4.24 To establish own library on collection of valuable books, palm leaf scripts, Tamra sanand and other scripts and arts available on any metals, clothes, leafs etc.
- 4.25 To issue appeals raise funds and accept gifts, donation subscriptions in cash or in kind and any property either movable or immovable for the achievement of the objective of the trust.
- 4.26 To acquire, purchase or otherwise own or under take on loan or lease or hire temporality or permanently and movable or immovable property necessary or convenient for the furtherance of the objects of the trust.
- 4.27 To organized and take-up Health, Educational and Welfare programmes for needy & poor Women & Children.
- 4.28 To promote and protect Indian Traditional music, dance, handicraft, handlooms, Art, modern art & literature.
- 4.29 To support the families and relatives of artists for promoting the budding artists in the trust;
- 4.30 To establish an award for the deserving people in the field of Music, Art grass root level social service, communal harmony, brotherhood and peace.
- 4.31 To purchase the movable and immovable property in the name of the Trust and to invest them in the manner suitable to raise more funds, so that the very objectives for making public developments, can be undertaken.
- 4.32 To establish centers for the promotion of Music, Dance and other Arts.
- 4.33 To establish residential and non-residential cultural centers for promoting Music, Dance and other Arts.



- 4.34 To work for Environmental Protection, Forestation, Plantation, Waste Land Management.
- 4.35 To organized vocational training for women and needy people.
- 4.36 To organized awareness camps, health camps, March, workshops, campaign and exhibition.
- 4.37 To aware people about their democratic & fundamental rights.
- 4.38 To promote cottage industries, *Khadi*, and traditional handicraft.
- 4.39 To advocate *Poanchayti Raj* system among citizens.
- 4.40 To provide various medical services such as organizing health and awareness camps of Immunization, Eye Care, Motherhood, Child Care, and Communicable Diseases.
- 4.41 To prevent any epidemics and to advocate both permanent and temporary measures of Family Planning.
- 4.42 To provide basic medical facility, sanitation, general health care and other needful support which can be helpful for public to overcome sufferings and agony of any natural and manmade disaster and to facilitate them to rehabilitate.
- 4.43 To provide medical, emotional, psychological, social and medical support to senior citizens of our trust by setting up various drop-in centres, senior citizen homes, old-age homes and other entertainment centres so that these highly honorable people should not be neglected.
- 4.44 To undertake activities for sensitizing people to preserve the natural resources of our nation and to maintain the ecological balance of the area.
- 4.45 To provide and facilitate legal assistance to underprivileged and poor section of trust to fight for their rights and justice.
- 4.46 To promote, encourage and facilitate research programmes and trainings in the field of public health, education and empowerment.
- 4.47 To arrange and organize religious, social and cultural programmes for all human being from time to time.



- 4.48 To create a sense of brotherhood, love, humanity, affection, cooperation and friendship amongst the members of the trust and the beneficiaries.
- 4.49 To make best efforts for promotion, development and protection of the beneficiary's/ target population and help them in distress.
- 4.50 To help poor, widows, handicapped, orphans, old aged, mentally retired and under privileged section of the trust/community.
- 4.51 To run/ operate different types of education program/schools like formal, non-formal, pre-school for the education development of under privileged children of the community/trust.
- 4.52 To run the different types of health programmes to raise the health status of vulnerable groups, poor and needy.
- 4.53 To work for the empowerment and sensitization of women, adolescents and children.
- 4.54 To make up efforts for the education, welfare and development of women, children and backward community in both urban and rural areas throughout the country.
- 4.55 To establish the medical facilities in the working locality (if required) such as family planning centers, dispensaries, hospitals etc.
- 4.56 To run and open the schools for the welfare and uplift of the needy children and also run adult education programmes.
- 4.57 To publish books, magazines, charts, issue related IEC (Information, Education and Communication) materials and other periodical illustration for generating the income for the trust for the benefit of its aims.
- 4.58 To work and fight against discrimination based on Cast, Creed, Colour, Gender, Religion, Faith, Race & Nationality.
- 4.59 To open / run / manage institute / collage of higher / professional / vocation education in any part of the country for providing quality education and training to youth and children.




- 4.60 To promote and protect natural herbs and plants by cultivation, preservation, storage, processing, demonstration, creating botanical garden and providing necessary training.
- 4.61 To establish / run / manage hospitals, health centres, mobile health clinics, research centre to provide health care, counseling and referral services for all kinds of illness and deceases.
- 4.62 To promote traditional therapies like Yoga, Naturopathy, Meditation, Acupressure, Acupuncture, Massage Therapy, Ayurveda, Homeopathy, Reiki etc.
- 4.63 To establish, build or manage Hostels, Short Stay Homes, Rehabilitation Centers, Shelters, Crèches, Child Care Centre or Children's Home, Counselling Centers and Help Line Centers for Women, Children, Old aged persons, Drug addicts and needy persons.
- 4.64 To work for the welfare of Agricultural workers, Farmers, Unorganized Labours, Industrial Labours and Migrated Labours.
- 4.65 To form women groups, youth groups, self-help groups; old aged groups, adolescent groups, children groups/clubs, community leader's groups and group of volunteers.
- 4.66 To promote traditional games along with the contemporary sports among youth & others.
- 4.67 To work for welfare & support for the families of Martyrs and Prisoners.
- 4.68 To work against the exploitation of Animals & Birds and make sincere efforts to protect them.
- 4.69 To celebrate annual day of the trust every year as cultural & social event.
- 4.70 To establish Citizen Forum s and Resident Welfare Association s for the development of high values of the Unity, Brotherhood, Communal Harmony and Peace.




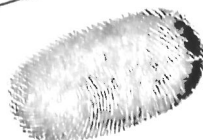
- 4.71 To promote and support voluntary donation of Blood, Eyes and other parts of human body for the charitable purpose.
 - 4.72 To take-up, initiate or assist social development activities or welfare programmes for bringing positive change in the lives of the common people.
 - 4.73 To save or protect National Heritage, Buildings or Places of the archeological & historic importance.
 - 4.74 To spread the teachings & thoughts of great leaders, philosophers, thinkers, reformers and saints.
05. AND GENERALLY to do in all public, charitable purposes for public benefit without any discrimination of Caste, Creed, Color, Gender, Religion, Faith, Race or any Nationality. That in case any of the objects of the Trust are held to be non-charitable within the meaning of section 2 (15) of the Indian Trust Act, or any statutory modification s thereof, the Trustee s shall not carry out such objectives.
06. **THE MAIN/CHIEF TRUSTREE SHALL HAVE THE FOLLOWING POWERS:**

- 6.1 To manage the properties, assets and funds of the Trust, from time to time, such regulations (not being inconsistent with this deed) as they may think fit for and necessary for the purposes of such management and control or in connection with the execution of any of the subject herein contained or powers hereby vested in them and may rescind or alter any such regulation.
- 6.2 To accept donations, contributions, grants, subscription in cash or in kind from any person, company, firm, association, organizations, government, non-government or semi government agencies, national or



foreign funding agencies, family Trust, or corporate bodies for furtherance and achievement of the objectives of the Trust.


- 6.3 To appoint a managing Trustee, when necessary.
- 6.4 To interpret and execute of the terms of this Trust Deed
- 6.5 To review the affairs of the Trust and a necessary.
- 6.6 To appoint officers and members of staff for the Trust and to prescribe their condition of service.
- 6.7 To open and to provide for operating banking accounts.
- 6.8 To raise loans with or without security or to invite donation and financial help.
- 6.9 The Chief Trustee may exercise the powers granted under this clause without requiring any resolution, consent, approval, or permission from any other trustee(s) or beneficiary(ies) of the trust.
- 6.10 To authorize persons to sign or execute documents on behalf of the Trust.
- 6.11 To grant receipts for aid or donation received.
- 6.12 The Chief Trustee shall have the exclusive right to make decisions on behalf of the trust, and no other trustee or beneficiary shall have the authority to challenge, override, or interfere with such decisions.
- 6.13 Any decision made by the Chief Trustee in the exercise of these powers shall be final, binding, and irrevocable.
- 6.14 All decisions made by the Chief Trustee in the exercise of these powers shall be documented in writing and maintained as part of the trust's official records.
- 6.15 The Chief Trustee shall act in the best interest of the trust and its beneficiaries while exercising these powers. However, the Chief Trustee shall not be held liable for any decisions made in good faith.
- 6.16 To acquire land or building on the lease or way of purchase.
- 6.17 To compromise, compound or refer to Arbitration all actions, proceedings and disputes relating to Trust property or properties.

- 6.18 To sell or give on rent/lease or on hire any immovable or moveable property of the Trust for some certain periods on such terms and conditions as the Chief Trustee may think fit and proper from time to time.
- 6.1 To open any type of bank accounts whether saving account, current account, fixed or otherwise, in the name of the Trust or institutions or programs run by the Trust with any scheduled banks or post offices and to operate by the authorized signatory or signatories as Board of Trustees shall think fit and proper to authorize any person or persons, unless and until determined otherwise the such bank accounts shall be opened and operated jointly with signatures of any two members of Board of Trustees. The financial year for the Trust shall be from 1st April to 31st March and the accounts of Trust or institutions or programs run by the Trust shall be audited yearly by the auditors or chartered accountant or a firm of chartered accountants to be appointed by the Chief Trustee and the fee for auditors, if paid, shall be a part of outgoing amounts from the Trust Funds.
- 6.2 To give guarantee of the assets and property of the Trust, including the bank guarantee on behalf of the Trust to carport bodies, persons, firms, institutions, as Chief Trustee may decide from time to time. The Trustees shall not be personally liable for such guarantees or the securities.
- 6.3 To gift, lease, and transfer the immovable and moveable properties of the Trust.
- 6.4 To appoint lawyer, pleaders, advocates to file and defend suit or suits filed for and against the Trust and or in the name of the Trust and also file suits for financial and other disputes or dues with different parties and signed executed such application, petition documents for such proceedings and delegate powers to the officers, employees, staffs and Trustees for such proceedings as required from time to time.

- 6.5 To appoint new member or members of Board of Trustees , to discharge any of the Trustee, who become bankrupt or acts in any manner prejudicial to the interest or objects of the Trust or is convicted of an offence involving moral turpitude or becomes of unsound mind or is otherwise unfit to continue as Trustee.
- 6.6 To appoint from time to time on such terms and conditions as they may determine a Secretary, Manager, Executive Director, Directors and other officers or members or staff for carrying out the activities of the Trust and to remove at any time any such Secretary, Manager, Executive Director, Directors and other officers or members or staff.
- 6.7 After defraying all necessary expenses incurred in the collection or realization of the income from the Trust ten percent (10%) of the balance of the income shall be kept in a reserve fund to be utilized when, in the opinion of the Chief Trustee, there is any emergency and the remaining income may be utilized for the purpose of the Trust.
- 6.8 The Chief Trustee shall invest the Trust fund in private/ government securities, saving certificates, fixed deposits or in any other form of investment authorized under provisions of INDIAN TRUST ACT and INDIAN INCOME TAX ACT, 1961, as he shall deem expedient.
- 6.9 It has further been decided that as and when the Trust is enclosed or dissolved all the funds of the Trust shall be transferred to the other recognized Public Charitable Trust having similar objectives.
- 6.10 All questions relating to the management of the Trust or the exercise of the powers vested in the Trust shall be decided at a meeting or, if necessary and expedient, by circulation. Every such question shall be decided by the Chief Trustee, as the case may be and any action or decision of such majority shall be as valid as if it was done or made by the all Trustees. The Chairman / Chairperson shall have a casting vote.

6.11 In case of occurrence of any vacancy amongst the Trustees because of death, resignation or incapacity of any Trustee or any other cause, a new Trustee may be appointed to fill the Vacancy.

6.12 All the incomes, earnings, movable / immovable properties of the trust shall be solely utilized and applied towards the promotion of its aims and object only as set forth in the Memorandum of the trust and no profit, thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any other manner whatsoever to the present or past members of the trust or to any person claiming through any one or more of the present or the past members.

6.13 No member of the trust shall have any personal claim on any moveable or immovable properties of the trust or make any profits, whatsoever, by virtue of this membership.

7 MEETING OF TRUSTEES:

7.1 The Chief Trustee shall preside over all the meetings of the trustees and in his absence any other trustee who is authorized in writing by the Chief Trustee shall preside such meeting;

7.2 The meetings of the Trustees may be convened by the Chief Trustee or under his direction by any other Trustees

7.3 The quorum of the meeting of the Trustees shall be two trustees personally present.

7.4 In the event of equality of votes, the person presiding such meeting shall exercise casting vote (additional vote).

7.5 For matters not provided for in these presents, the provisions of the Indian Trust Act, 1882 and the Income Tax Act, 1961 and rules made there under will apply accordingly.

8 A Trustee shall cease to be the trustee of the Trust if:

8.1 he resigns;

8.2 he becomes insolvent;

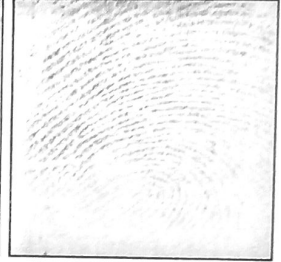
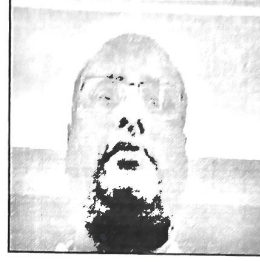

- 8.4 he fails without obtaining leave or absence to attend three consecutive meetings of the board of trustees;
- 8.5 he is removed by the other members of the Board of Trustees by obtaining final approval of Managing Trustee, if it is found that the trustees activities are detrimental to the activities or administration or funds of the Trust
- 8.6 in case of death or inability to work due to accident etc.
- 9 The Main Trustee shall have full power and authority to make, alter and rescind rules and regulations for the management and administration of the Trust having.
